- 1) **\$250.00 non-refundable application;**
- 2) **Certificate of Insurance for Dram Shop Coverage in the Amount of \$ 1,000,000.00 (one million dollars); and**
- 3) **Required by Illinois State Law as of July 1, 2016 all servers and sellers of alcoholic liquor must submit valid copies of BASSET training certification or a copy of their BASSET license.**

In addition, all expenses incurred by the Village, as a result of the processing of the application, shall be paid by the applicant.
